

## DUTY FREE SHIPMENT OF PERSONAL AND HOUSEHOLD GOODS

### General Information

In compliance with the applicable provisions of the law, the importation into Italy of personal effects, furnishings, books, vehicles, radio equipment, televisions and HI-FI systems (indicating the make, model and serial number of the appliance), tools and utensils necessary for work, as well as other household objects belonging to Italian citizens who transfer their residence from abroad to the Republic, is permitted.

For this purpose, a certificate issued by the competent consular authorities must be presented to the Customs Office in Italy, certifying that all required requisites are met.

### WHO CAN, AND HOW TO REQUEST CUSTOMS EXEMPTION

For the issue of the aforementioned certificate, the interested **party must be registered with A.I.R.E. (Register of Italian Residents Abroad) for at least twelve months** and go to the Consulate without an appointment, during opening hours, with the following documents / forms filled out.

- Italian Passport
- Declaration of transferal of residence
- Declaration of commitment/description(of audio-visual equipment)

To check if you have actually been registered with AIRE for at least 12 months and therefore if you are entitled to the customs exemption, you can fill in the declarations, scan them and send them by e-mail to [consolato.adelaide@esteri.it](mailto:consolato.adelaide@esteri.it) requesting this information.

The consular declaration is released on demand and is free of charge.
