1	Proof of financial means: Regular and consistent income as shown in bank statement (at least 3 months) deriving from property, stable economic and/or commercial activities or from other sources. The amount required is of at least EUR 2,600.00 per applicant per month. Please note that this visa does not allow any work activities in Italy. Therefore you cannot finance your residence in Italy through any type of work;	<input type="checkbox"/>
2	Proof of lodging: contract of purchase/leasing of house or apartment in Italy. The leasing contract must be duly registered at the Italian Taxation Office (Agenzia delle Entrate). No invitation letter fulfils this requirement. Please note that ownership of a yacht or other type of boat does not fulfil the requirement either.	<input type="checkbox"/>
3	If applicable, originals of marriage certificate for the spouse and birth certificates for the children (plus 1 copy of each certificate);	<input type="checkbox"/>

2	If minors travel <u>with one</u> of their legal guardian(s): (1) consent of the parental authority or legal guardian not travelling with the minor must be provided through a notarised certificate (Justice of the peace) or a form signed at the consulate; (2) photocopy of passport of the authorising parental authority or legal guardian(s); (3) copy of original birth certificate of the minor issued by the responsible authority translated into English	<input type="checkbox"/>

1	Proof of being a highly qualified worker in that specific field certified by one of the following: a) Bachelor degree (or higher) or a high professional qualification of at least three years b) High professional qualification of at least five years (if self-employed: trade/business license/registration and tax assessment for the last five years; if employed: contract, 2 pay slips per year and employer letter with details of experience achieved, starting and ending date) c) If the applicant holds one of the professions listed here – the qualification must be assessed by the competent Italian authorities before submission of visa application d) If the applicant is a manager or specialist in ICT, three years professional qualification certificate	<input type="checkbox"/>
2	Only for remote salary employed: proof of remote employment contract with indication of role, date of employment, salary (not less than EUR 33,000/year); letter from the employer accompanied by photo ID declaring absence of conviction against him/her in the last five years as per article 22 (5b) of Italian legislative decree n.286/1998	<input type="checkbox"/>
